These have been delivered online and/or onsite reporting organisational effectiveness against drivers of real performance, as well as compliance. This has greatly enhanced ISO 9001, internal process audits, customer satisfaction assessment activity for many organisations. Ian is well published having written a number of books on System Thinking including providing significant 'real world' experience for a CSR book entitled: *Implementing Effective Corporate Social Responsibility and Corporate Governance – A Guide*, published by the British Standards Institution (Bsi).

Sameh Sakr is an assistant professor of finance at Sultan Qaboos University in Muscat, Oman. He has published papers in areas of corporate governance; mergers and acquisitions; and the effect of regulation.
